("CANACOL") DECLARED A DIVIDEND OF CAD\$0.052 PER SHARE PAYABLE ON JULY 15, 2021 TO SHAREHOLDERS OF RECORD AT THE CLOSE OF BUSINESS ON JUNE 30, 2021.**

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ **CANACOL HAS REASONABLY DETERMINED THAT IS IS NOT LIKELY TO HAVE POSITIVE ACCUMULATED EARNINGS AND PROFITS ("E&P") OR CURRENT E&P FOR THE YEAR ENDED DECEMBER 31, 2021. ACCORDINGLY, THE DISTRIBUTION IS LIKELY TO BE TREATED AS A SECTION 301(c)(2) RETURN OF BASIS FOR U.S. FEDERAL INCOME TAX PURPOSES.**
